

Introductions of new NWRC Executive Director and NWSSB Members

Each board member introduced themselves to NWRC's new Executive Director, Amanda McDade.

Amanda McDade introduced herself and provided a brief overview of her background. She has been with NWRC approximately six years as the Case Management Director and is excited about taking on the Executive Director role.

Introduction of Darla Smith as NWRC's new Office Supervisor.

The Board requested discussion on:

Background information on the Northwest Senior Services Board was provided by Ryan Blackwell. The original direction for the Board was to have input and guidance from seniors, however, this role is changing to be more advocacy based. Additionally, the Board acts as a sounding board for new programs prior to being presented to the Governing Board.

Discussion ensued around the possible need for a secretary that can help track and send out informational and marketing materials, possibly a type of advocacy liaison role. It was felt that more outreach is needed in the community. A request was made for informational materials be made available throughout the community, perhaps through the various Senior Centers.

Conversation continued around growth trends and impacts of these trends, especially in the ratio of available caregivers to those persons who need them.

Agency Update

COVID Update

NWRC had planned to restart home visits in December of 2021. Due to the impacts of the current variant, this plan has since been changed to a triage approach allowing for varying types of visits such as "porch" and remote contact based on risk factors for both the client and staff. The majority of our staff continue to work remotely. Staffing levels have been impacted by Covid.

NWRC 2022 Budget Summary

Amanda McDade shared that Dan Murphy reviewed the 2022 budget summary at the last NWSSB meeting in November, and that she was open to answer any questions. A question was presented regarding the administrative costs. Ryan Blackwell offered that though he has not seen the current analytics, the administrative costs usually run around 10%.

Discussion centered around nutrition and why the budget seemed to have gone down when the understanding was that it would stay even for this program. The

budget is based on a per unit cost. It is possible that during COVID, the number of meals served went down which could make it appear that the budget was reduced. The per unit cost remained flat. There was a request to have a report on the number of meals served. Whatcom Council on Aging is the service provider and would need to provide that information. Discussion circled around the possibility that supply chain issues could be impacting the cost. Ryan Blackwell noted there is an increase in per unit cost, which reflects inflation and the supply chain issues we have all been seeing. A request was made for a detailed report on NWRC COVID funds obtained and their distribution.

Legislative Update

Advocacy Updates

The legislative session started yesterday, January 10th. This is essentially a clean-up year and there is more in available in the budget than anticipated. NWRC is focused on several issues that are also being advocated for by larger agencies such as AARP and SEIU. NWRC has a goal to increase funding for case management that reflects the same increase the state received. The caseloads for NWRC staff are very heavy and have become much more complex. Increased funding would allow for NWRC to reduce the caseload enabling a higher level of service for our case managed clients.

The Long-Term Care Act premiums have been placed on hold for the time being by Governor Inslee, allowing for time to address some of the issues in the bill.

Acute Care Hospital Transitions – Additional funding is being sought for this program. Movement to employ 30 additional care coordinators state-wide. This means approximately 2 additional staff for each area. NWRC staffs two positions, with one care coordinator stationed in Skagit and one in Whatcom hospitals. The staff in these positions are imbedded in with the hospital staff allowing care to continue longer, making sure that needs are in place for the client to transition from hospital to home easier and be more successful. This program has proven to reduce 30-day hospital readmissions dramatically 57% to 13%. Page 17 of this packet.

Personal Needs Allowance – There is a request to increase this allowance from 100% of the Federal Poverty Level to 300% for individuals needing in-home care. Currently, the PNA is \$1,074 per month for an unmarried individual, with the remaining two-thirds (on a \$3,000/mo. income) going to their providers to pay for their care. Many adults, needing care and choosing to stay in their homes will refuse, or accept less care hours in order to keep the cost down. Page 19 of this packet.

State Council on Aging Update (SCOA) - Georgiann Dustin

The SCOA is also advocating for increasing the personal needs allowance. SEIU and AARP are also advocating for this request. In addition, the SCOA is advocating for higher salaries and additional training for caregivers. SCOA is contemplating in-person and hybrid meetings for a potential start in April.






